



## Gymnastics Victoria MAG High Performance Program 2019 Fee Policy

1. Athletes over the age of 18 must agree in writing to abide by this fee policy in order to train in the Gymnastics Victoria (GV) MAG High Performance Program (Program)
2. A parent/guardian for athletes under the age of 18 must agree in writing to abide by this fee policy in order for a participant (Gymnast) to train in the Gymnastics Victoria (GV) MAG High Performance Program (Program)
3. This policy applies to all expenses, including GST, due to and invoiced by GV for Gymnasts participating in the program. Expenses include but are not limited to fees, uniforms, support services, competition entries and travel expenses
4. Gymnasts withdrawing from the Program must provide notice in writing to GV one (1) month in advance. Fees will be charged up to the conclusion of the one (1) months' notice. Fees will be charged regardless of whether or not the Gymnast trains during the notice period. All other accounts in relation to the Gymnast's participation in the Program must also be settled by the conclusion of one (1) months' notice.
5. If a Gymnast withdraws or is asked to leave the Program, all outstanding amounts must be paid within one (1) month. Failure to do so may result in legal action to recover the outstanding amount (plus any additional charge). Any fees, costs or disbursements incurred in recovering any outstanding monies including debt collection agency fees, solicitor's costs and court fees will be added to the account.
6. Gymnasts who have concluded participating in the program and leave with any amounts outstanding will not be permitted to participate in any GV events or activities until all outstanding payments have been settled.

### Fees

7. GV will conduct the Program and set the relevant Program tuition fees (Fees).
8. Fees are reviewed annually, with GV reserving the right to increase Fees at other times at its discretion. All fee increases will be advised in writing.

9. Fees are due for participation in the Program for each month or part thereof. No Fee rebates will be provided for missed or incomplete sessions or for withdrawal midway through any relevant payment period. If a Gymnast is injured they are expected to attend training for rehabilitation, strength, and conditioning if it is determined by the Program as safe to do so. In the rare circumstance where it may not be safe to attend the training environment other arrangements may be made at GV's discretion.
10. Fees are calculated based on the number of hours the Gymnast trains. No rebates are applicable if the Gymnast trains less than their scheduled hours in any relevant payment period. All Gymnasts are expected to participate in training during school holidays as advised and will be charged regardless of whether or not they attend such school holiday training. If a Gymnast moves to different number of training hours and therefore a different Fee, they will be charged the new Fee from the first day of their changed hours.
11. Fees will be collected on the first of each month from the credit card or debit card nominated on the accompanying form. Should the first of the month fall on a weekend or public holiday processing will take place on the next business day.
12. If a parent or gymnast wishes to pay for a full Terms' tuition in advance then they are entitled to a 5% discount on the tuition fees. Please contact GV Finance.

#### Charges

13. Charges for uniforms, support services, competition entries, travel, or any other expenses in relation to participation in the Program are to be paid within 14 days from receipt of the invoice.

#### Bond

14. A bond payment of \$300.00 is required prior to commencement for gymnasts training 10+ hours per week. This bond is refundable (less any outstanding monies) once a gymnast concludes participating in the program.
